Chair Kobliska called the meeting of the Black Hawk County Metropolitan Area Transportation Policy Board to order at 10:00 AM.

The first item was approval of the agenda. It was moved by Middleton, seconded by Becker to approve the agenda as presented. Motion carried unanimously.

Next was to review and consider approval of the minutes for the September 14, 2023 meeting. It was moved by Middleton, seconded by Smock to approve the minutes. Motion carried unanimously.

Next was to review and consider approval of the Iowa DOT's Highway Safety Improvement Program (HSIP) 2020-2024 targets for the MPO. Durant explained that State DOTs and MPOs are required to adopt safety performance targets annually. The Iowa DOT adopted their next round of HSIP targets, and the MPO must approve their own targets. MPOs can set their own targets or adopt the Iowa DOT's targets. To date, the MPO has adopted State targets, and MPO staff recommend continuing this approach. There being no further discussion, it was moved by Smock, seconded by Becker to approve the Iowa DOT's HSIP 2020-2024 targets for the MPO as follows:

Motion carried unanimously.

Next was to review and consider approval of the Carbon Reduction Program (CRP) Guidelines for the MPO. The group agreed to modify eligible projects to allow both on- and off-road non-motorized accommodations. It was moved by Kobliska, seconded by Middleton to approve the CRP Guidelines for the MPO with the suggested change. Motion carried unanimously.

#### Next was Discussion Items:

1. Review the draft Transportation Alternatives Set-Aside Project Selection & Programming Guidelines for the MPO.

Durant said the lowa DOT has published the revised TA Set-Aside guidelines, as mandated by the existing federal transportation legislation. MPO staff prepared updated guidelines that closely align with those of the state. Durant discussed significant changes including eligible project sponsors, the project criteria, and the project scoring and programming process. Each jurisdiction is encouraged to review the draft guidelines and provide comments. Staff anticipate presenting the finalized guidelines for approval at the upcoming November meeting.

2. Iowa DOT annual update to the Infrastructure Condition Evaluation (ICE).

Durant mentioned that the Iowa DOT conducts an annual Infrastructure Condition Evaluation using multiple criteria, providing a comprehensive assessment of Iowa's Primary Highway System. The assessment identifies highlights highway segments that could be considered for further study for improvements. The Iowa DOT produces both reports and an interactive online map as part of this analysis.

## 3. Project Updates

a. City and county project updates (TAP & STBG)

#### **Cedar Falls**

Wicke said the Main Street project has completed main line paving from 6<sup>th</sup> to 11<sup>th</sup> Street and 18<sup>th</sup> to 22<sup>nd</sup> Street. Sidewalks and driveway approaches will be worked on next. The culvert at Seerley Boulevard has been completed and construction on the roundabouts will be starting soon.

#### Waterloo

Schindel said the deck on Park Avenue bridge is complete. The bridge is anticipated to be fully open in late spring or early summer of 2024. The 11<sup>th</sup> Street bridge is progressing forward with substructures. The La Porte Road project is moving along with its RAISE grant to scope out Phase II and III. As soon as the grant agreement is approved by the DOT, Phase I may move forward with letting. The project is anticipated to be let next year.

#### DOT

Schindel said four alternatives are still being reviewed for the IA 58 interchange at Greenhill Road. PCI is continuing work between the IA 58 and 20 interchange, which will carry into next year.

b. MET Transit Study

Sturch said the consultant has shifted to the zero-emissions plan portion of the study. MET hopes to launch the restructured fixed routes late this year or early next year.

c. SS4A Comprehensive Safety Action Plan, Downtown Waterloo

Dautović reported that MPO staff initiated a proposal solicitation process in September, but no proposals were submitted. In response, staff have requested the for a project schedule

revision through the FHWA and intend to reissue the proposal solicitation as soon as possible. The second solicitation process is anticipated to include sending requests for proposals to consultants.

#### d. NEIA NEPA Study

Kobliska reported that a Consultant Selection Committee, representing the various jurisdictions participating in this project, met to review the preliminary Request for Proposal (RFP). Durant added that the RFP has been sent to the Iowa DOT for their review and evaluation, with the aim of obtaining approval to proceed with the consultant selection process in the upcoming weeks.

In general discussion, Durant mentioned that the MPO staff submitted a grant application on behalf of the City of Waterloo to the Reconnecting Communities and Neighborhoods Program. This grant aims to provide funding for the Downtown Railyard Relocation and Railroad Crossing Improvement Study. The proposed study will comprehensively assess the social, environmental, and safety impacts associated with the CN Railyard, as well as evaluate the feasibility of relocating it. Shindel added that AECOM submitted a grant application, representing the City of Waterloo, to the same program. Their proposal seeks funding for the development of multimodal enhancements and improvements along 4<sup>th</sup>, 5<sup>th</sup>, and 6<sup>th</sup> Streets from Kimball Ave to MLK Jr. Dr. The project encompasses converting one-way streets to two-way streets, adding non-motorized accommodations along the entire corridor, constructing a roundabout at Six Corners, and upgrading stormwater infrastructure. The announcement of grant awards is expected in the early part of next year.

There being no further business, it was moved by Kaspari, seconded by Becker to adjourn the meeting. Motion carried unanimously. The meeting was adjourned at 11:23 AM.
